MEMORANDUM OF UNDERSTANDING (MoU) BETWEEN Dr. C.V. RAMAN UNIVERSITY, KARGI ROAD, KOTA, BILASPUR, (C.G.)

PENDRAROAD- GAURELLA-PENDRA-MARWAHI C.G.

This MoU is entered into on the 15 day of June, 2019 by and between Dept. of Life Science, Dr. C. V. Raman University (hereinafter called LS-CVRU) situated at Kargi Road, Kota, Bilaspur, (C.G.), Established in 2006 as Chhattisgarh's first Private University, named after India's first Nobel Laureate, Dr. C.V. Raman University, Kota, Bilaspur C.G.

and, Govt. Pt. Madhav Rao Sapre College, Pendraroad, Gaurella-Pendra-Marwahi District C.G.(hereinafter called PMRSC)

1. Objectives of the MoU

The Objectives of the MoU are:

- a) To promote and enhance academic interest between LS-CVRU and PMRSC
- To promote research/ continuing activities between LS-CVRU and PMRSC
- c) To cooperate in Educational areas of mutual interest.
- 2. Technical Areas of Collaboration
 - a) Provide academic interaction by Delivering Expert Lectures.
 - b) Provide the platform to share and exchange of Best Practices.
 - c) A continuing Quality Improvement Programmes to improve the quality of Teaching.
 - d) To facilitate the training and Career Enhancement Program.
 - e) To facilitate the exchange program of Staff, Students and Interns.
- 3. Proposed Modes of Collaboration

LS-CVRU and PMRSC propose to collaborate through the following:

- a) Cooperation and promotion of education and training in area of mutual interest.
- b) Any other appropriate mode of interaction agreed upon between LS-CVRU and Govt. PMRSC

4. Terms and Conditions

- a) Nothing contained in this agreement is intended, nor shall it be constructed as creating a partnership or joint venture neither between the parties, nor as creating or requiring any ongoing or continuing relationship or commitment between LS-CVRU and Govt. PMRSC beyond the relationship specially created by this MoU. Unless specifically provided otherwise herein, No party, or representative shall be deemed to be a representative, agent or employee of any other party by contract, by employment or for any purpose whatsoever.
- b) Both LS-CVRU and Govt. PMRSC, agree to help, identify and invite the faculty members and researchers from other institutes to participate in Conferences, Workshops and Short-term courses.
- c) This MoU may be amended, renewed and terminated by mutual written agreement of the Parties at any time.
- d) Either Party shall have the right to terminate this MoU upon 90 days prior written notice to the other parties.

5. Confidentiality

- a) During the term of this MoU and after termination of this MoU, each Party will treat all information exchanged by the Parties or its employees as confidential. All information will be treated the property of the disclosing Party and will be returned to it immediately on request.
- b) LS-CVRU and Govt. PMRSC acknowledge that during the term of this MoU, each party may have access to certain know-how, technical or otherwise, disclosed to it by the other Party in connection with a Project or Activity ('Know-how'). It is agreed that Govt. PMRSC Knowhow shall be provided to each Party on an 'as-needed' basis and this MoU does not create any license or permission to use rights in favor of the other Party or any of its respective affiliates, employees, agents or consultants. Both LS-CVRU and Govt. PMRSC acknowledge and agree that the disclosing Party is the sole and exclusive owner or the licensed user of the Know-how and that the receiving Party has no right or title in or to the Know-how. Also, LS-CVRU and Govt. PMRSC each undertake and warrant that it shall not make any use, nor will it permit or authorize any use directly or indirectly of the Know-how, for any purpose other than for which the same has been disclosed pursuant to this MoU nor will it offer or provide any information, access to or assistance concerning the said know-how to any person, firm or undertaking without prior written consent.

6. Duration of MoU

This MoU, unless extended by mutual written consent of the parties,

shall expire in FIVE years after the effective date specified in the opening paragraph. However, on review, the MoU shall be extended by mutual consent.

7. Coordinators:

Both parties will designate persons who will have responsibility for coordination and implementation of this agreement.

8. Miscellaneous

- a) This MoU constitutes the entire agreement between the Parties here to with respect to the subject matter thereof and supersedes and replaces any and all prior agreements, communications, representations and understandings between the Parties, whetheroral or written.
- b) Any notice or other communication provided for in this MoU shall be in writing and may be first transmitted electronically or by facsimile transmission, and then confirmed by registered post, acknowledgement due or by internationally recognized courier service, in the manner as elected by the Party, as the case may be, giving Govt. PMRSC notice directed at the addresses of the parties specified in this Agreement.
- c) Each party acknowledges that the extent of the intended cooperative activities will be limited by the resources of each party and the parties agree to work together to identify and obtain appropriate third-party support for any cooperative activities.

9. Signed in Duplicate

This MoU is executed in duplicate with each copying being an official version and having equal legal validity. By signing below, the parties, acting by their duly authorized officers, have caused this Memorandum of Understanding to be executed, effective as of the day and year first above written.

The parties do not intend to be legally bound to each other, and this MEMORENDUM OF UNDERSTANDING does not impose legal obligations on either party.

3. Notices

- Any dispute or difference arisen out of this MEMORENDUM OF UNDERSTANDING shall be resolved through amicable settlement.
- Each party shall co-indemnify and hold each party harmless for any and all costs or expenses associated with damages or claims arising out of activities commenced under this MEMORENDUM OF UNDERSTANDING, or any act or omission of the party, its employees or others acting on its behalf while undertaking any aspect of these cooperative activities.
- This MEMORENDUM OF UNDERSTANDING is in two originals, and both parties shall hold one original copy.
